We are hopeful for continued growth and support in 2018.

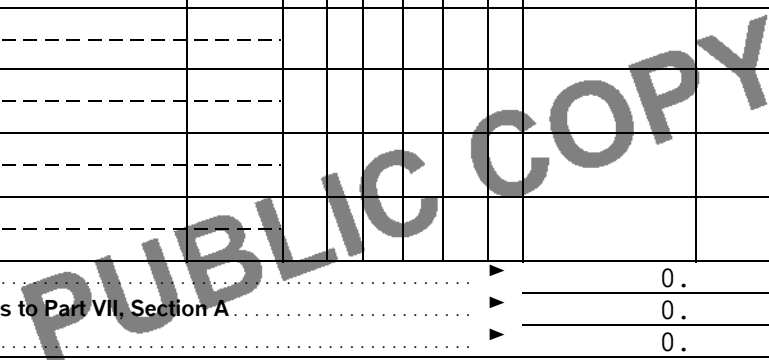

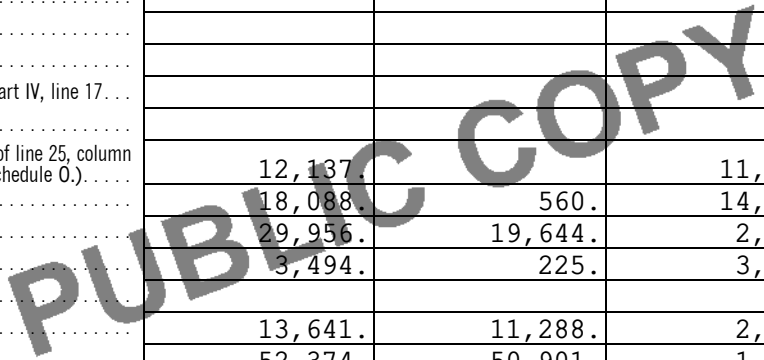

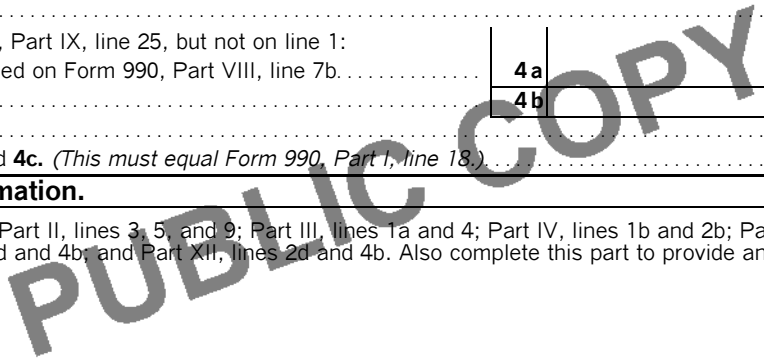
